JOINDER AND ADOPTION AGREEMENT

This JOINDER AND ADOPTION AGREEMENT (this "<u>Agreement</u>") is made as of ______, 2020, by and among Community Supported Solar for Farms LLC, a New Hampshire limited liability company (the "<u>Company</u>"), and each party set forth on the signature page hereto (each, a "<u>Subscriber</u>" and collectively, the "<u>Subscribers</u>").

WHEREAS, on May 4, 2020, the Company and the Host Member of the Company entered into that certain Operating Agreement (as the same may be amended from time to time, the "Operating Agreement");

WHEREAS, capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Operating Agreement;

WHEREAS, contemporaneously with the execution and delivery of this Agreement, the Subscribers propose to acquire Shares of the Company pursuant to that certain Subscription Agreement by and among the Company and Subscribers (the "Subscription"); and

WHEREAS, in connection with the Subscription, the Company, the Host Member, the Manager and the Subscribers desire that the Subscribers execute and deliver this Agreement, thereby becoming parties to the Operating Agreement, and that the Manager amend and restate Schedule A to the Operating Agreement to reflect the Subscription and the admission of the Subscribers as Participating Members of the Company..

NOW, THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties to this Agreement hereby agree as follows:

- 1. Agreement to Adopt and be Bound. Each Subscriber hereby agrees that upon execution and delivery of this Agreement, such Subscriber does hereby adopt and become a party to the Operating Agreement as a "Participating Member" for all purposes thereof and shall be fully bound by, and subject to, all of the covenants, terms and conditions of the Operating Agreement as though an original party thereto, and the Company and Manager do hereby admit each Subscriber as a Participating Member of the Company.
- 2. <u>Amendment and Restatement of Schedule A to the Operating Agreement</u>. Effective upon the execution and delivery of this Agreement, Schedule A to the Operating Agreement shall be amended and restated in its entirety to be as set forth in **Exhibit A** to this Agreement.
- 3. <u>Successors and Assigns</u>. Except as otherwise provided herein, this Agreement shall bind and inure to the benefit of and be enforceable by the (i) Company and its successors and assigns and (ii) each Subscriber and any subsequent holders of the Shares acquired by the Subscriber in connection with the Subscription and delivery of this Agreement.
- 4. <u>Counterparts</u>. This Agreement may be executed in separate counterparts and such counterparts may be exchanged electronically, each of which shall be an original and all of which taken together shall constitute one and the same agreement.

- 5. <u>Notices</u>. For purposes of <u>Section 10.2</u> of the Operating Agreement, all notices, or other communications to the Subscribers shall be directed to the addresses set forth in <u>Exhibit A</u> attached hereto.
- 6. <u>Descriptive Headings</u>. The descriptive headings of this Agreement are inserted for convenience only and do not constitute a part of this Agreement.
